CERTIFICATION OF GENERAL ELECTION.

ELECTION RETURNS OF MAY 10, 2011

THIS IS TO CERTIFY that the undersigned, Board of Supervisors of Elections for the Town of Hampstead, duly appointed by the Mayor and qualified in accordance with the provisions of Section 66-74 of Article 6 of the Code of Public Local Laws of Maryland, Title "Carroll County", sub-title "Hampstead", did, on the 10th day of May, 2011, (it being the second Tuesday of said month), between the hours of seven o'clock A.M. and eight o'clock P.M., hold an election at the Hampstead Town Hall in Hampstead, Maryland, for the purpose of the election of two persons to act as members of the Council of said Town and one person to act as Mayor, for a term of four (4) years, beginning on the next regular Council meeting after the election, being Thursday, May 12, 2011; and that, before proceeding with said election, appointed Barbara Burke to act as Clerk of said election and immediately upon the closing of said election, the ballots were counted, and the total number of votes cast in said election for each candidate for the respective offices were as follows, to wit:
